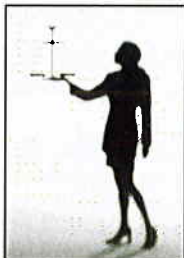
2010 SEMINAR and PARALEGAL DAY

Karen Greer McGee, *ACP*, First Deputy Clerk for the Second Circuit Court of Appeal in Shreveport, and a member of both the Louisiana State Paralegal Association and the Northwest Louisiana Paralegal Association, has been elected President of NALA, The Association of Legal Assistants/Paralegals.

She was elected for the 2010–11 term during the March 6 meeting of the NALA Board of Directors at the Association's national headquarters in Tulsa, OK, and brings many years of leadership experience to her role as President. She will officially take office in July at NALA's 35th Annual Meeting in Jacksonville, FL.

She has said that her focus for her term of office is continued development of NALA's top-quality educational and certification programs for all paralegals, and the greater use of technology to foster communication and involvement among NALA members. She will also be working with the NALA Board of Directors on ideas and programs to further serve the expectations of NALA members, and to advance the paralegal career field.

Ms. McGee has been a paralegal since 1988, earned the NALA Certified Paralegal credential in 1990, and earned her Advanced Certified Paralegal (ACP) in the field of civil litigation in 1994. She is a graduate of the Institute of Paralegal Studies at Louisiana State University, Shreveport, LA.
